





MEMORANDUM OF UNDERSTANDING

DEPARTMENT OF GEOGRAPHY, KAMPUR COLLEGE, KAMPUR AND DEPARTMENT OF GEOGRAPHY, RAHA COLLEGE, NAGAON

Date :

This Memorandum of Understanding (MoU) is entered into by the Department of Geography, Kampur College, Kampur (hereinafter referred to as the first party) and the Department of Geography, Raha College (hereinafter referred to as the second party), with the common objective of fostering academic collaboration in the field of geography through faculty exchange, student exchange, joint research activities, and field-based learning.

Both parties agree to the following terms and conditions:

1. **Objective:** The primary aim of this MoU is to collaborate in the areas of faculty exchange, student exchange, joint research, field trips, and other geography-related academic activities.
2. **Validity:** This MoU will be valid for a period of three (3) years from the date of signing and may be renewed upon mutual agreement.
3. **Faculty Exchange:** Both parties agree to facilitate the exchange of faculty members for guest lectures, workshops, or short-term teaching programs.
4. **Student Exchange:** Both parties agree to offer students the opportunity to participate in academic programs and activities organized by either institution.
5. **Research Collaboration:** The departments shall collaborate in geographical research including data collection, analysis, and publication of joint papers.
6. **Field Trips:** Joint field visits and geographical surveys shall be conducted to enhance the practical understanding of students and faculty.
7. **Seminars & Workshops:** The institutions shall co-host seminars, conferences, and workshops on contemporary geographical issues.
8. **Resource Sharing:** Both parties may share academic resources, including library access, GIS labs, and research tools where feasible.
9. **Termination:** Either party may terminate this MoU at any time by giving written notice to the other party.


10. Compliance: Both parties shall ensure adherence to their respective institutional policies and government regulations during collaborative activities.



